Client or Third Party Attack Surface	<ul style="list-style-type: none"> Assessment of client's cybersecurity posture or third party that evaluates evidence of system compromise, compromised account credentials, vulnerabilities in externally facing applications, spear-phishing risk, and online indication and warnings
Person of Interest (POI) Investigation	<ul style="list-style-type: none"> Investigation into an internal or external POI that attempts to establish the real identity and future actions of a poster, a threat agent, or other individual of interest
Malware/File Analysis	<ul style="list-style-type: none"> Reverse engineering of a suspicious malware sample or file, obtaining Indicators Of Compromise (IOCs), linking to possible author, campaign, and/or malware family
Threat Actor Profile Research	<ul style="list-style-type: none"> Research and analysis of a bad actor's Tactics, Techniques, and Procedures (TTPs), links to any campaigns, investigation into motivation, group affiliations, and online presence
Campaign/Breach Research	<ul style="list-style-type: none"> Attempts to establish attribution, malware campaign tracking, attack scope determination, size, who's affected, and who has the wild data
Domain Investigation/Analysis	<ul style="list-style-type: none"> Investigation and analysis of suspicious domains or IP addresses for any malicious activities, links to known campaigns or threat actors, or past threat activity
Event/Pre-event Security Briefing	<ul style="list-style-type: none"> A formal report detailing the risks and vulnerabilities associated with an event of interest
Due Dilligence/Company of Interest Investigation	<ul style="list-style-type: none"> Investigation into a business of interest to include legal risks, regulatory compliance matters and sanctions review, reputation risks, and executives profile review
Travel Advisory	<ul style="list-style-type: none"> A formal report detailing physical, cyber, and geopolitical risks associated with a designated geographic region or county/location of interest
